Description: Harness, Extension, WBA x2/x3

Usage: This three (3) foot long extension harness simplifies testing of the WBA-12/13/22/23 using power and communications supplied by the game.

Note: JCM Engineering designed this harness so technicians can perform testing on the casino floor. The harness can also be used to extend the harnessing on the PS-15-006 (Part No. 550-100042) diagnostic power supply with the adapter harness (Part. No. 400-100109) allowing more flexibility at the electronics test bench.

Customer Notification/Tech Tips:

Question: What is the process for ordering software for my machines?

Answer: JCM's Software Order Form can be obtained by calling (800) 683-7248 and asking for the Parts Department. The following information must be supplied on the form to assure your order is filled correctly:

Model Number - The unit name, model, and style (e.g, WBA-12-SS)

ID - This is the communication protocol (e.g., ID-024)

OEM - The manufacturer of the host machine (e.g., IGT)

Version and Checksum - This is the version and electronic identification of the software being ordered. If the latest approved software is requested, just enter "Latest Version."

Format - The storage format for the software, either EPROM or 3.5" floppy disk.

Type - Choose between a Master, which includes a duplication license, or a copy which does not.

Quantity - Indicate the quantity of software and labels being ordered.
