# Notice on Changes of the Effective Dates for Corporate Split of Amusement Industry Division and Merger of Subsidiaries

Japan Cash Machine Co., Ltd. (hereinafter referred to as the "Company") hereby notifies that the Comapny decided to change the effective dates regarding corporate split of amusement industry division and merger of subsidiaries. As publicly announced on May 8, 2009, in "Notice of Corporate Split of Amusement Industry Division and Merger of Subsidiaries", it was resolved that the Company implements 1) business succession by its 100% consolidated subsidiary (JCM Systems Co., Ltd., hereinafter referred to as "JCM Systems"), under corporate split of the businesses of sales and manufacturing of pachinko machines and pachisuro related amusement products and running of amusement centers and 2) absorption of the Company's 100% consolidated subsidiary (JCM Techno Support Co., Ltd.) by JCM Systems. However, the Company decided to change 1) the scheduled split date (effective date) of the business related to running amusement centers and 2) the scheduled merger date (effective date).

#### 1. Changes

#### ①Corporate split

The Company changes the effective date of business succession by JCM Systems, under corporate split of the businesses of sales and manufacturing of pachinko and pachisuro related amusement products and running amusement centers as below.

<sup>\*</sup>This split requires an authorization from the prefectural public safety commissions based on the "Act on Control and Improvement of Amusement Business, etc". The date above assumes that the Company receives the relevant authorization before the scheduled split date.

## ②Merger of subsidiaries

The Company changes the effective date of merger, by absorption of JCM Techno Support Co., Ltd. by JCM systems as below.

### 2. Reasons of Changes

Originally, the Company scheduled the effective dates of corporate split and merger of subsidiaries on July 1, 2009. However, it turned out that the procedures for the split of amusement industry division and the merger of subsidiaries take more time than expected. Therefore, the Company changes the scheduled split date (effective date) to August 1, 2009, and the scheduled merger date (effective date) to October 1, 2009.

Regarding sales and manufacturing of pachinko machines and pachisuro related amusement products, the scheduled split date (effective date) remains unchanged, i.e. July 1, 2009.
